Motor Vehicle Taxation: The motor vehicle excise tax is a tax on the privilege of registration. Automobiles and trailers are valued according to the number of days each was registered in the previous calendar year (January 1, 2018 to December 31, 2018 inclusive). If a vehicle is sold and not replaced, or if you move and register the vehicle out of state, the registration must be cancelled and the plates returned to the RI DMV. A cancellation receipt will be provided by the DMV and should be kept for your records. Should you choose to retain your plate after disposal of the vehicle or registration out of state, the vehicle will be taxed until said registration expires.

Motor Vehicle Value: The value of the vehicle is mandated by law to be the "Average Retail Value" as determined by the Rhode Island Vehicle Value Commission. This determination is made by using the National Automobile Dealers Used Car Guides and other recognized pricing guides. Physical condition, high mileage, and/or cost of acquisition are NOT grounds to appeal your vehicle assessment.

Motor Vehicle Phase-Out: Effective fiscal year 2000 (last amended 2017), the State of Rhode Island, through enabling legislation, implemented a phase-out of the motor vehicle tax. A pro-rated exemption has been applied to each vehicle (see Rhode Island General Law 44-34-1-1 for specifics).
